Re: Service Cuts

The Connecticut Department of Transportation has informed WRTD and all of the other Transportation Districts that they will be receiving 15% cuts to their operating budget this year. The funding cut is currently scheduled to take place on July 1st, 2018.

This funding cut is in response to the budget that was passed last year that did not have enough transportation funding in it.

In response to this funding cut, WRTD will need to cut bus service. The following cuts are being proposed:

Route 32: The loop that runs every day from 11:04 am until 1:09 pm.

Willimantic – Danielson: All Service

Storrs – Willimantic: The following loops will be eliminated during the weekdays on UConn's Fall, Winter, Spring and Summer Breaks:

6:30 am – 8:08 am
8:16 am – 9:44 am
2:30 pm – 3:50 pm
3:52 pm – 5:12 pm
5:14 pm – 6:25 pm
