TITLE VI Discrimination Complaint Procedures

Any person who believes that he/she, individually, as a member of any specific class, or in connection with any Disadvantaged Business Enterprise, has been subjected to discrimination prohibited by Title VI of the Civil Rights Act of 1964, the American with Disabilities Act of 1990, Section 504 of the Vocational Rehabilitation Act of 1973 and the Civil Rights Restoration Act of 1987, as amended, may file a complaint with the Windham Region Transit District. A complaint may also be filed by a representative on behalf of such a person.

The complaint must meet the following requirements:

- a. Complaints shall be in writing and signed by complainants. In cases where the Complainant is unable or incapable of providing a written statement, a verbal complaint may be made. If necessary, Windham Region Transit District staff will assist in reducing the complaint to write and submit a written version of the complaint to the person for signature.
- b. Include the date of the alleged act of discrimination date of when the complainant became aware of the alleged act of discrimination; or the date on which the conduct was discontinued or the latest instance of conduct.
- c. Present a detailed description of the issues, including names and job titles of those individuals perceived as parties to the complaint.
- d. Federal and state law requires complaints to be filed within 180 calendar days of the alleged incident.

Upon receipt of the complaint, the Windham Region Transit District Planning Director will determine its jurisdiction, acceptability, and/or need for additional information. The complainant will be provided with a written acknowledgement that Windham Region Transit District has either accepted or rejected the complaint.

A complaint may be dismissed for the following reasons:

- e. The complainant requests the withdrawal of the complaint.
- f. The complainant fails to respond to requests for additional information needed to process the complaint.
- g. The complainant cannot be located after reasonable attempts.

The allegations will be investigated by the Windham Region Transit District Planner, and based on the information obtained, a recommendation for action in a report of findings will be issued to the Executive Director. The complaint should be resolved by informal means whenever possible. Such information attempts and their results will be summarized in the report of findings.

The Executive Director will notify the complainant in writing of the final decision reached, including the proposed disposition of the matter. The notification will advise the complainant of this/her appeal rights with the appropriate

Windham Region Transit District will provide the appropriate Federal or State agency with a copy of the decision and summary of findings upon completion of the investigation.
